Independent Auditors' Review Report on Unaudited Standalone Quarterly Results



We have reviewed the accompanying unaudited standalone financial results of **Sumuka Agro Industries Limited** (formerly Superb Papers Limited, Surat, Gujarat) (hereafter the Company) for the quarter ended on 30th September, 2016 (the financial results).
